THE FOLLOWING PROGRAMS ARE OFFERED: CAMP BOB WALDORF SUMMER CAMP, TEAM BOB WALDORF (TBW) WEEKEND CAMP, WITHERBEE WILDERNESS BACKPACKING, KIBBUTZ BOB WALDORF SUMMER CAMP, KIBBUTZ BOB WALDORF WEEKEND CAMP, AND A COUNSELOR-IN-TRAINING PROGRAM DURING THE SUMMER.
